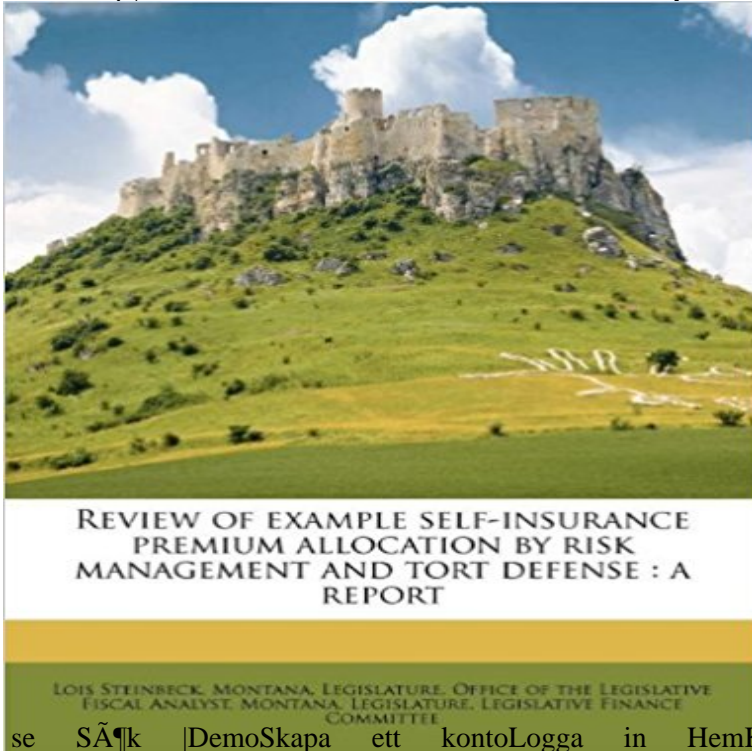


Review of example self-insurance premium allocation by risk management and tort defense: a report Volume 1992
