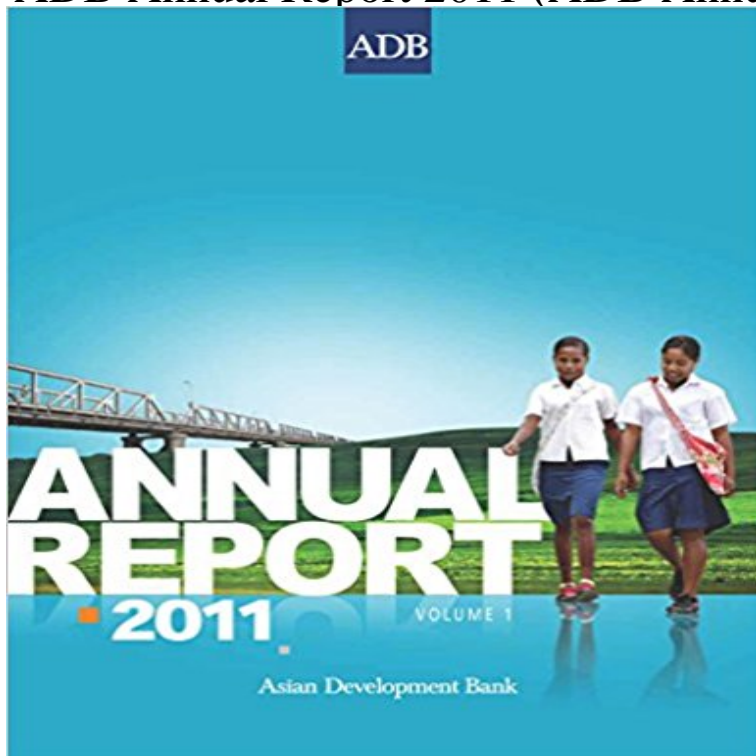


## ADB Annual Report 2011 (ADB Annual Reports)



In 2011, the Asian Development Bank (ADB) approved \$21.72 billion in financing operations, representing a 14.5% increase on 2010 financing, according to the latest Annual Report of the Board of Directors to the Board of Governors.
