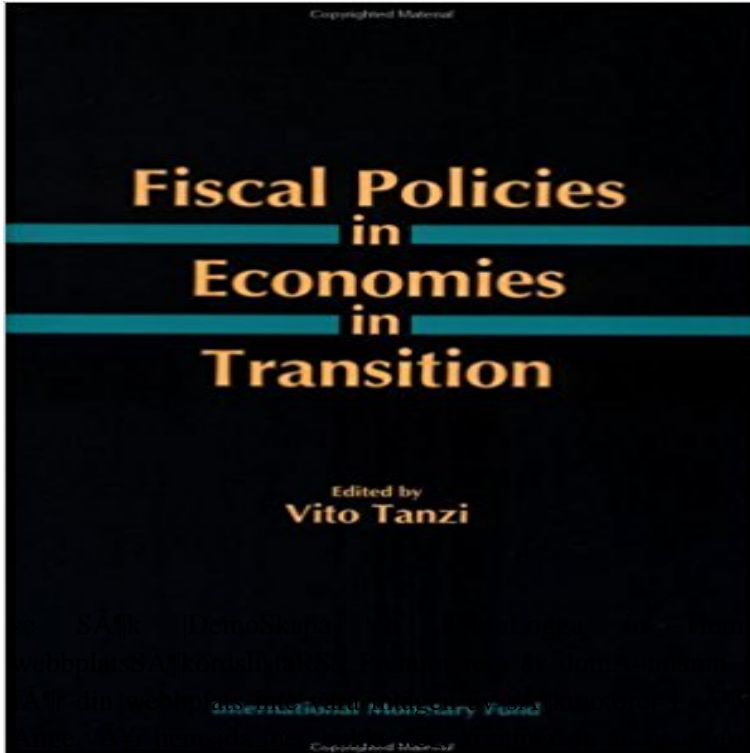


Fiscal Policies in Economies in Transition
