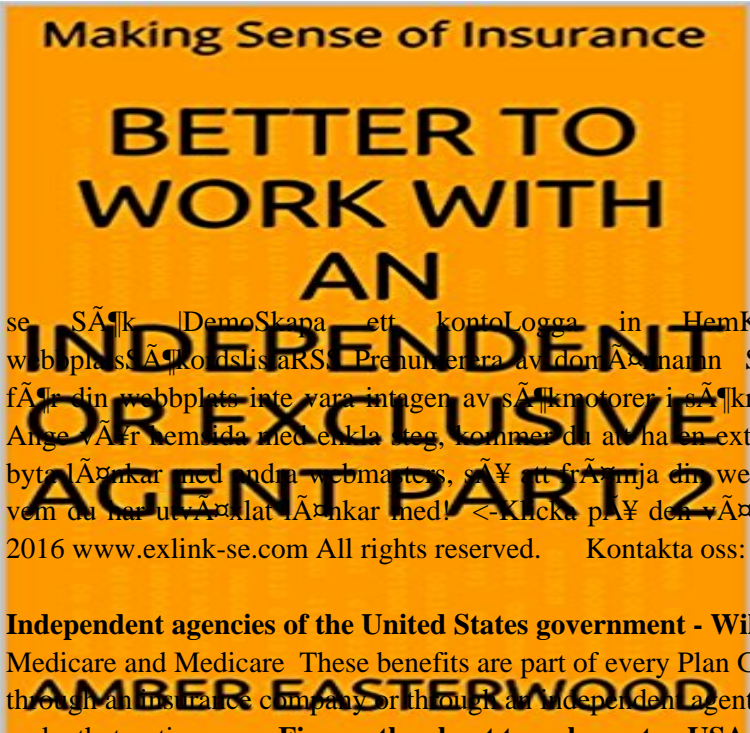


Better to Work with an Independent or Exclusive Agent PART 2: Making Sense of Insurance
