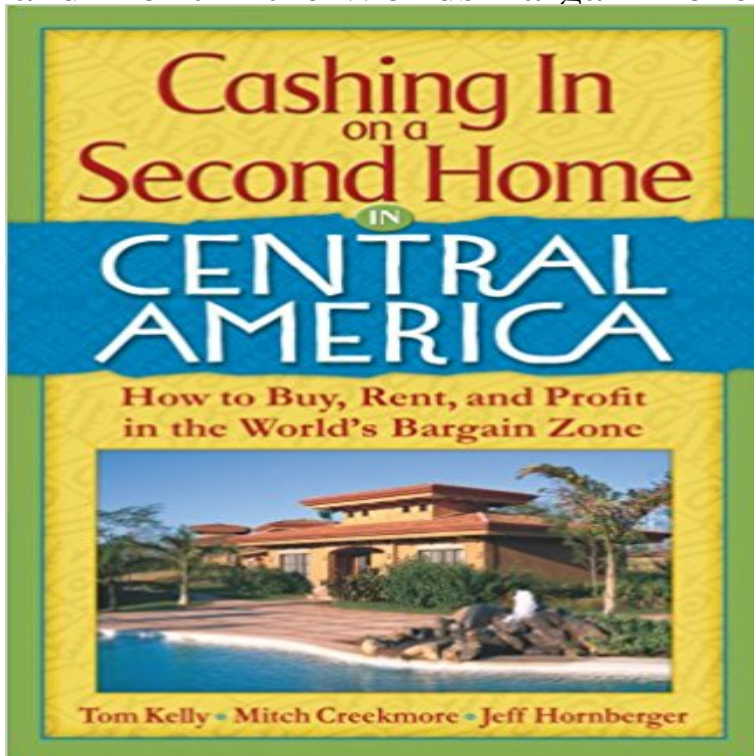


Cashing In On a Second Home in Central America: How to Buy, Rent and Profit in the Worlds Bargain Zone

Great personal wealth has been attained through real estate ownership, but for most of us, it has been limited to investment in a primary residence. Although Mexican real estate also can be a viable investment venue, Americans have had a great deal more trepidation considering property south of the border. And for good reason—considering the history of some acquisitions. Given today's investment climate, however, Mexico provides an
