The plan of treatment, which we will call the Lott-Pettey plan of treatment, and we shall in a general way briefly outline. The treatment of Dr. Lott is as follows: Examine heart and kidneys of patient, give him warm bath and put him to bed, have a thoroughly reliable and competent nurse to be with patient constantly. Give him the usual dose of morphine one or two hours before commencing the treatment. Begin with 1-100 of a grain of hyoscine hydrobromate and 1-20 of strychnine nitrate, and give 1-200 of a grain of the hydrobromate of hyoscine thirty to forty-five minutes to one hour until the amount is determined which will affect the patient, and then the same dose is given every hour for forty-eight hours. The pulse is carefully watched, and a dose of strychnine, digitalin or nitroglycerine given occasionally as indicated. At the end of the forty-eight hours, the patient is usually allowed to come from under the influence of the drug, and soon wakes up and says he feels well. It is necessary to impress upon him the fact that the length of time for treatment will depend upon his having reached a point when he feels sure he will not want the drug again, then administer pilocarpine 1-8 grain, as required, and it may be necessary to re-inforce this with strychnine, 1-20. The mouth which has been dry under the hyoscine treatment, becomes, under the action of pilocarpine filled with saliva from

stimulation of the salivary glands, the urine becomes abundant, clear, the skin very active...
