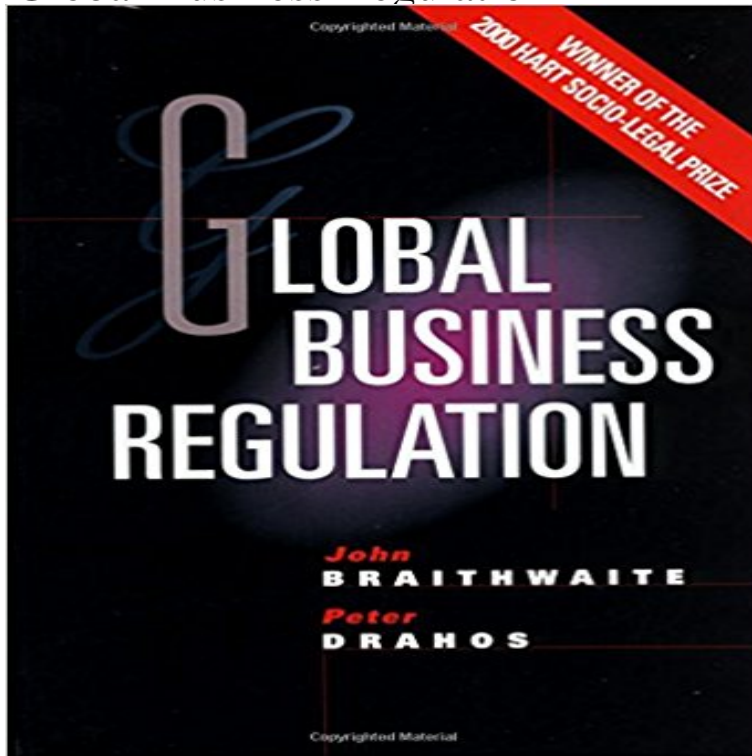


# Global Business Regulation
