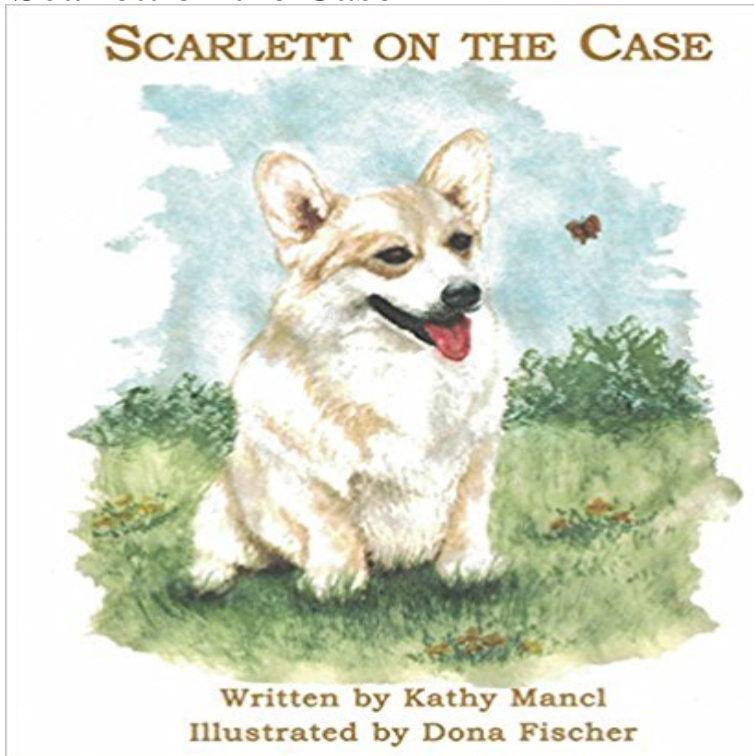


## Scarlett on the Case
