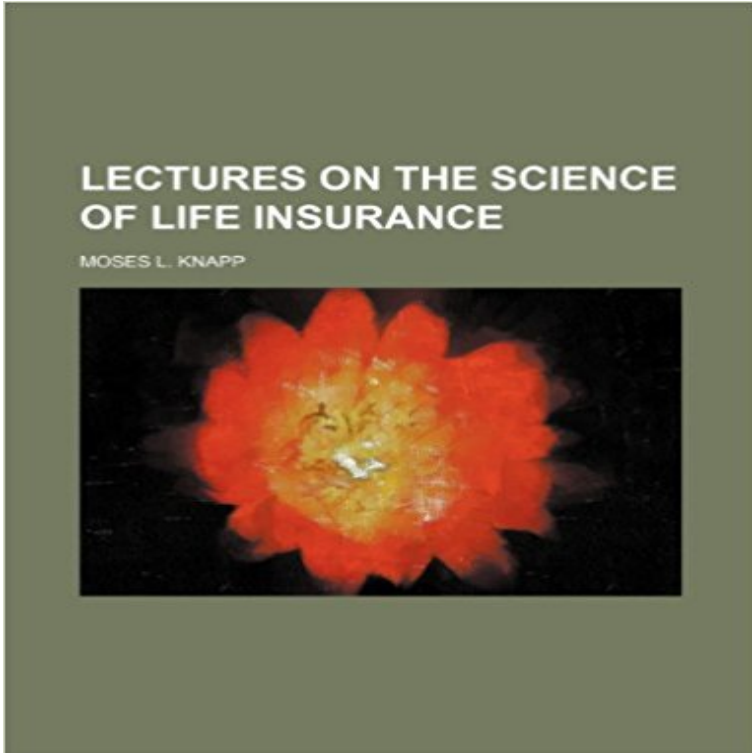

Careful people do not like to be near danger. High-minded, honorable, cash-paying members will never desire to thrive upon the ruin of their fellow credit subscribers, or be found aiding and abetting a system so utterly devoid of Life Insurance science, common sense or sound principles; and which might, in the opinion of any person, render them liable to indictment by a Grand Jury. Can the notes be collected?--The tacit understanding is, the notes are never to be collected; or, this may be the verbal understanding and agreement with agents. If the insured
