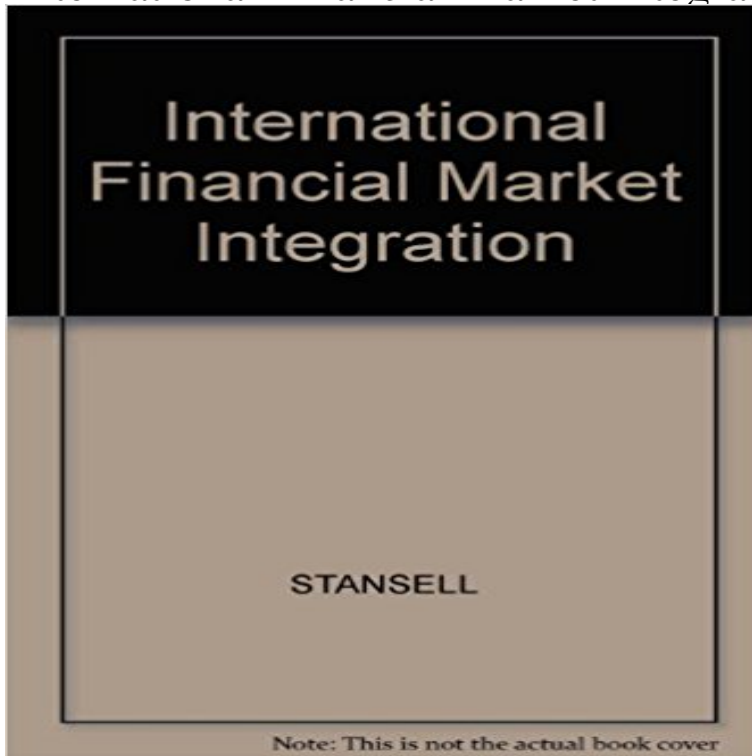


International Financial Market Integration

Areas covered include capital market segmentation, an examination of the US banks, international financial market integration and commercial sheet strategies of US banks, international financial market integration and commercial banks, the European monetary system, international integration of the CIS and Baltic States emanating from the USSR, an overview of Japanese finance, international transmission of stock market movements and international capital markets. This text should be a valuable reference for academics, graduate students and researchers in international finance.
