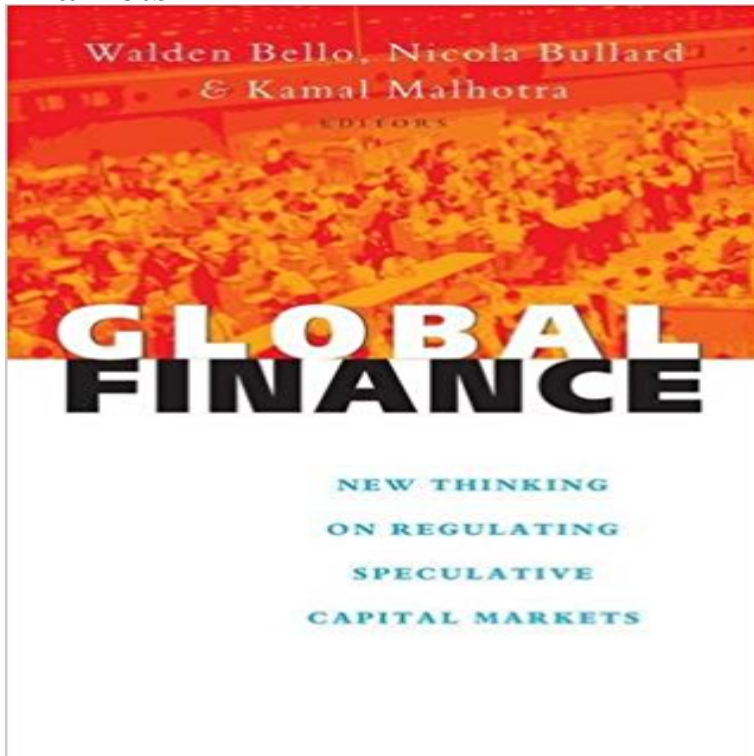


Global Finance: New Thinking on Regulating Speculative Capital Markets
