

# Uncitral Model Law on International Commercial Conciliation with Guide to Enactment and Use 2002



This publication sets out the resolution adopted by the UNs General Assembly on Model Law on International Commercial Conciliation for the year 2002, and which was originally defined in the Official Records of the General Assembly, 57th session, supplement 17 (A/57/17) (ISBN 0119891646). The law is aimed at resolving trade disputes between countries, and also aims to enhance conciliation and dispute law in individual countries, by seeking uniformity in the law, and also avoiding lengthy litigation procedures.
