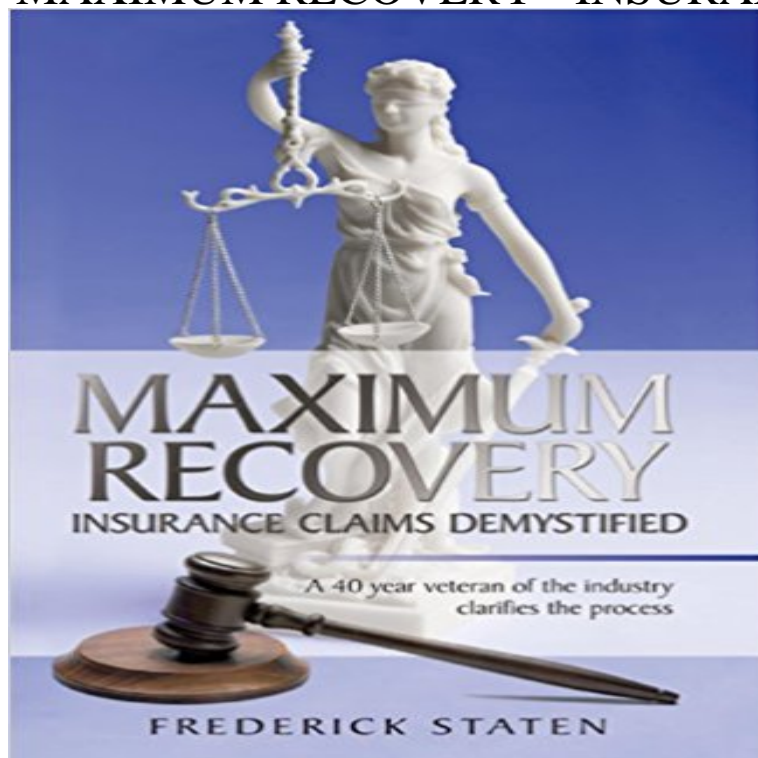


# MAXIMUM RECOVERY - INSURANCE CLAIMS DEMYSTIFIED

The section dealing with automobile property damage will disclose some cash you may have overlooked. You are probably not legally liable for the damage, but you can be a good guy and pay the cost to repair under a special coverage in your homeowners policy. What are your rights with respect to claims against the manufacturer or vendor of the product?
