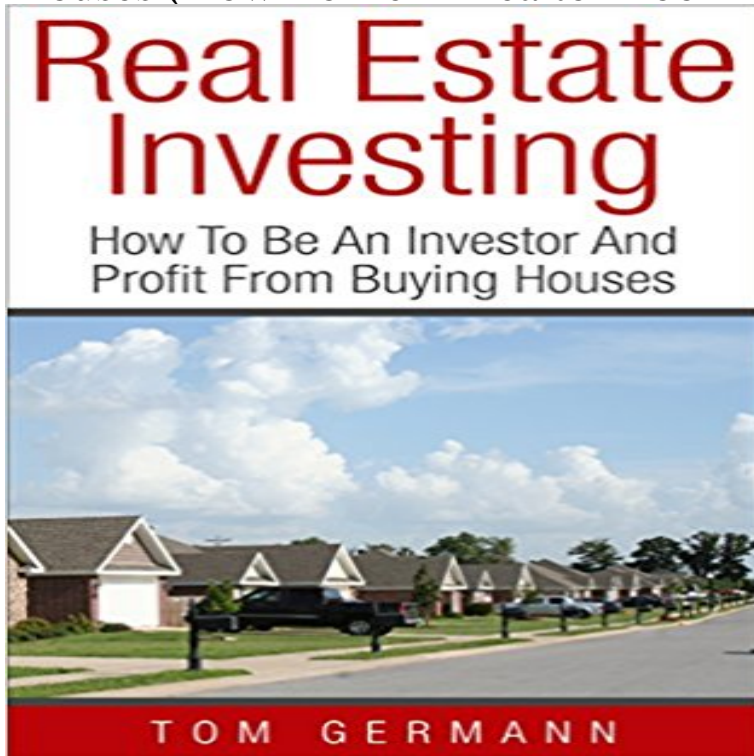


Real Estate Investing: How To Be An Investor And Profit From Buying Houses (How To Be A Realtor Book 4)
