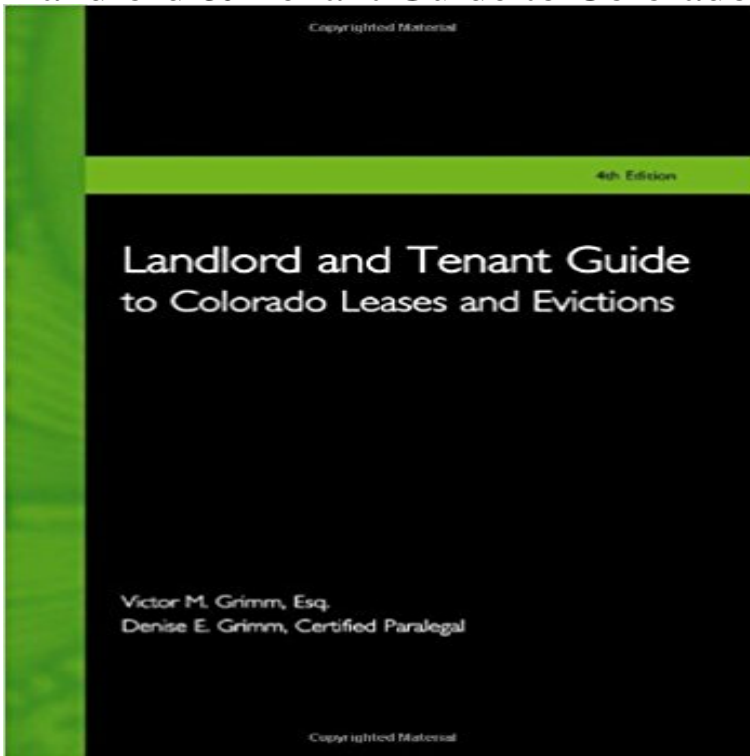


Landlord & Tenant Guide to Colorado Leases and Evictions, 4th Edition
