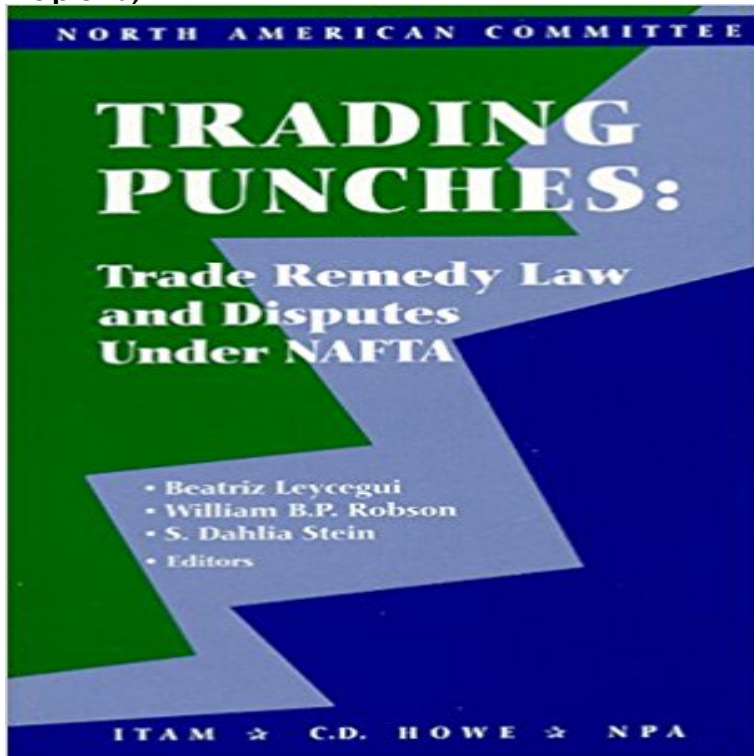


Trading Punches: Trade Remedy Law and Disputes Under NAFTA (NPA report)



As traditional barriers to commerce among the economies of North America have come down, the remaining impediments have become more prominent. Antidumping and countervailing duty actions launched by each of the NAFTA partners against exports of the others are a notable example of this tendency. With the aim of promoting better relations through a clearer understanding of the economic challenges and opportunities within the NAFTA partnership, NPAs North American Committee has published this volume, which contains chapters by 18 authors on the use of trade remedy laws in North America. The study provides background on the legal framework of the so-called unfair trade laws in each of the three countries as well as on the dispute-settlement mechanisms available under NAFTA and the World Trade Organization. It also provides some empirical analysis of the effects of these laws and puts forward ideas for reform.
