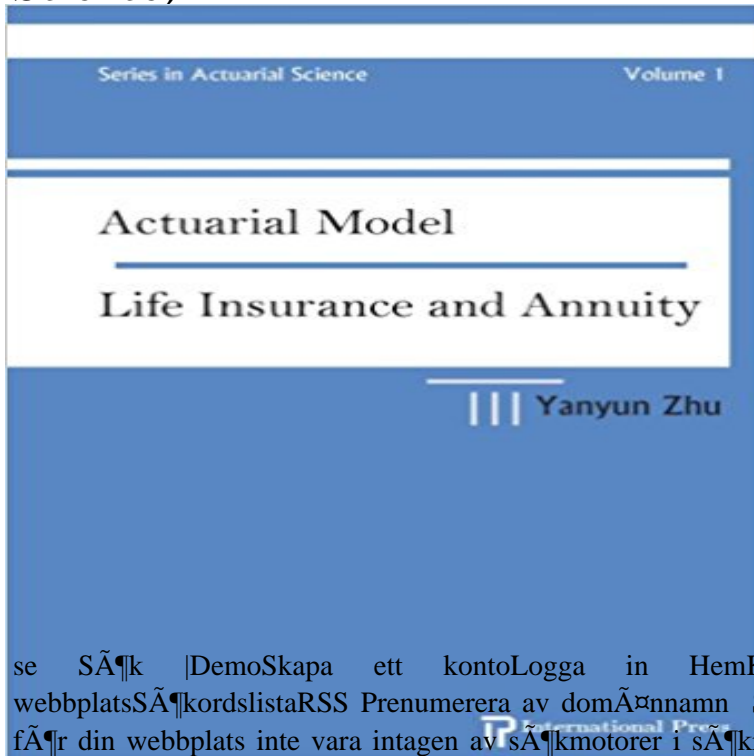


Actuarial Model: Life Insurance and Annuity (Series in Actuarial Science)
