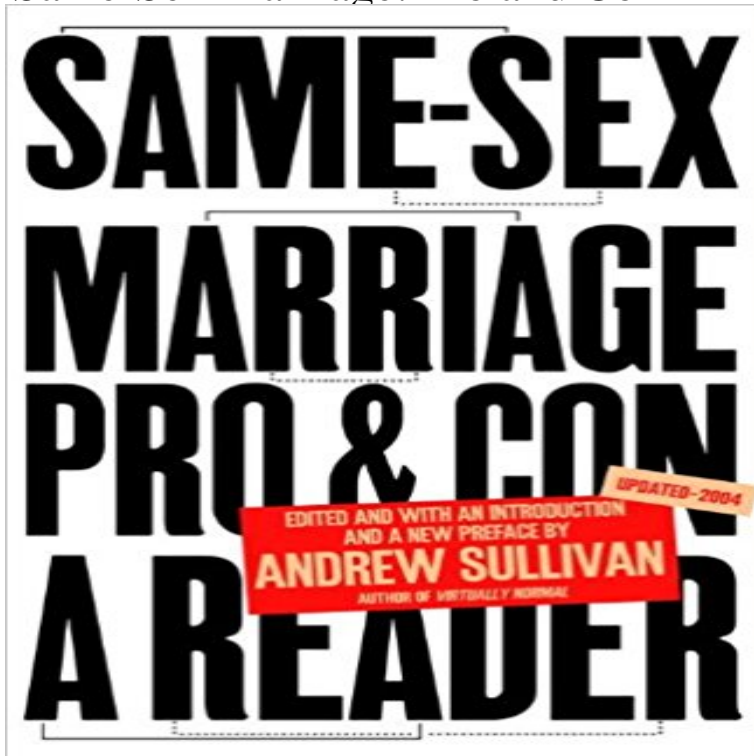


## Same-Sex Marriage: Pro and Con
