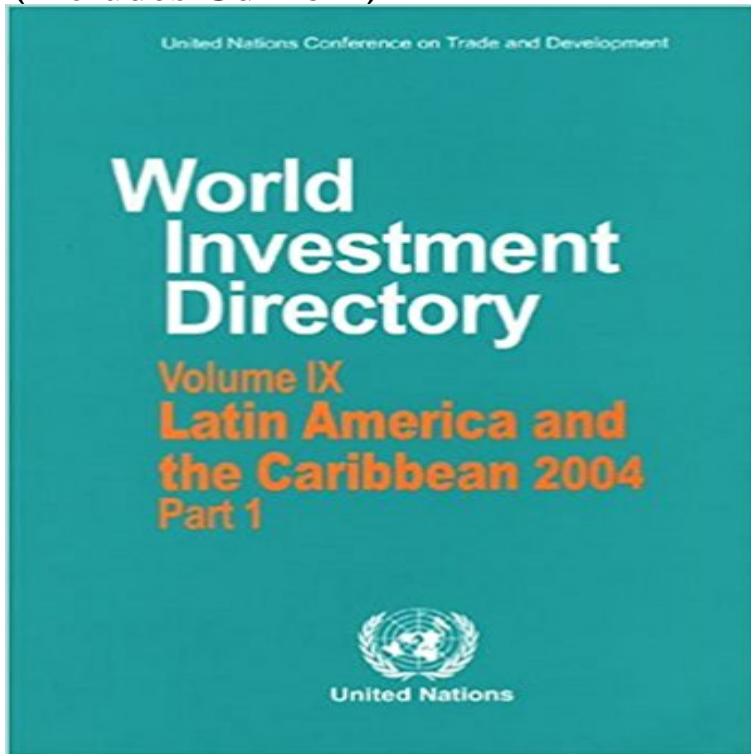


World Investment Directory 2004: Latin America and the Caribbean (includes Cd Rom)
