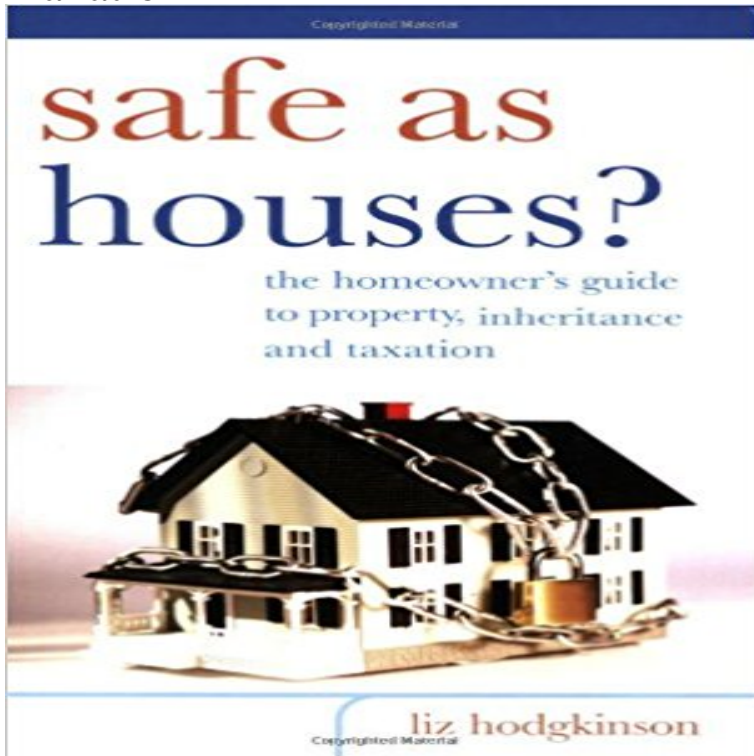


Safe as Houses?: The Homeowners Guide to Property, Inheritance and Taxation
