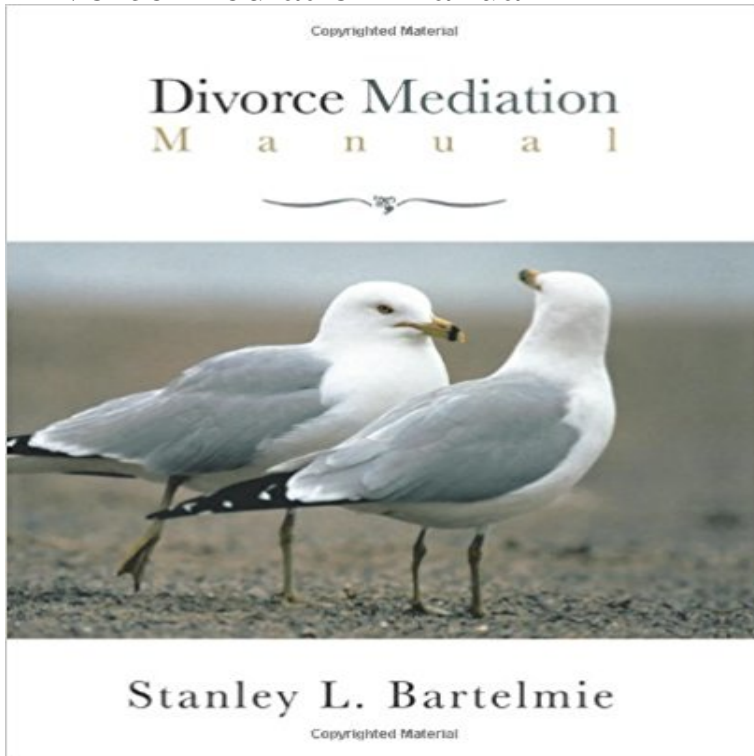


# Divorce Mediation Manual
