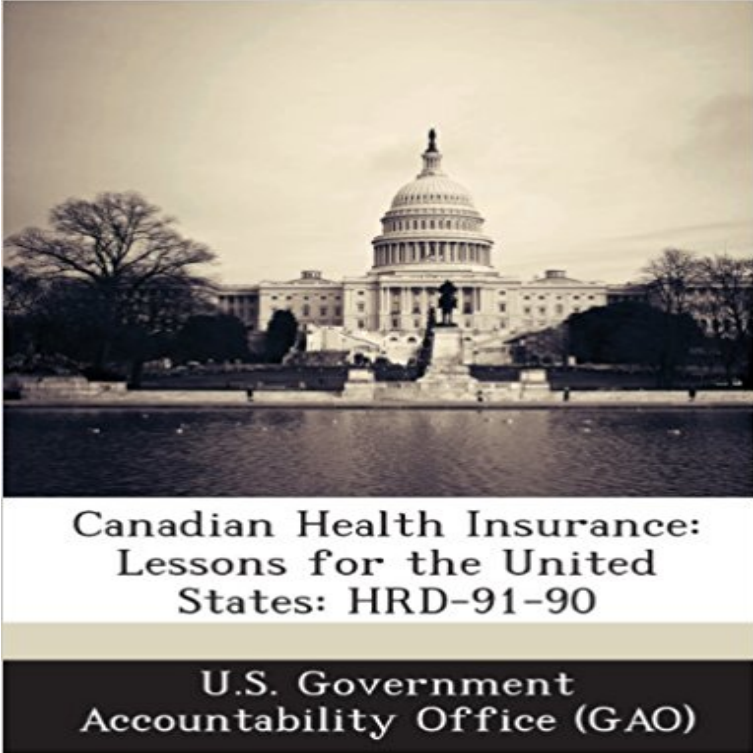


Canadian Health Insurance: Lessons for the United States: Hrd-91-90
