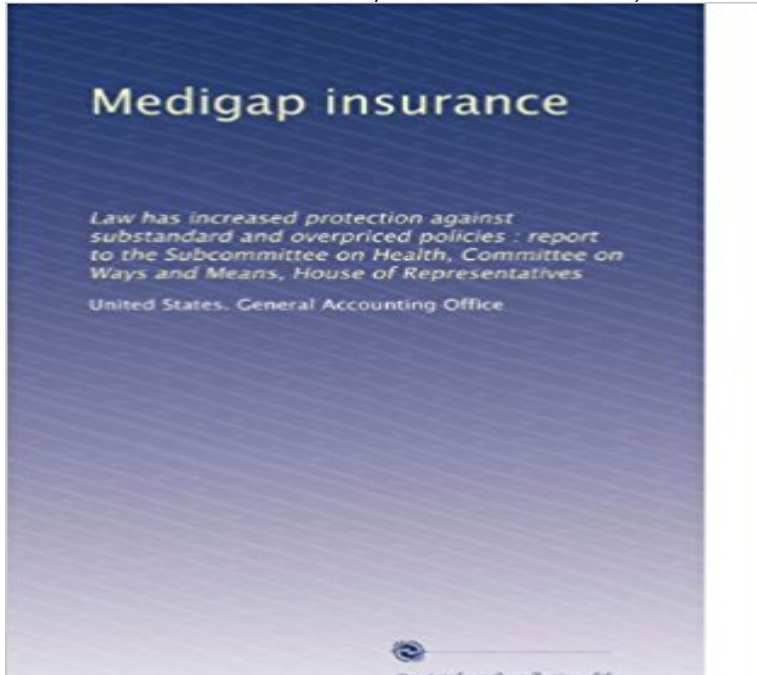


Medigap insurance: Law has increased protection against substandard and overpriced policies : report to the Subcommittee on Health, Committee on Ways and Means, House of Representatives
