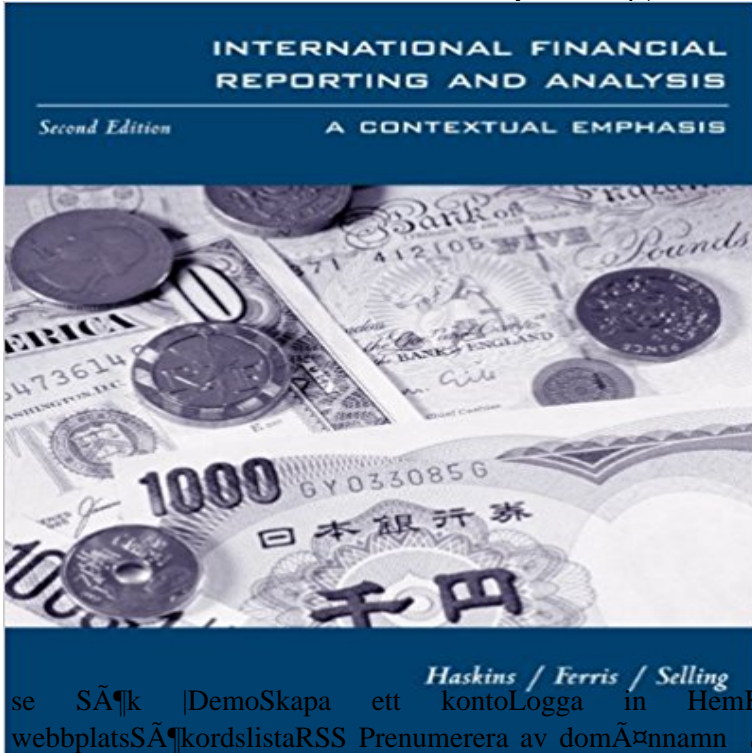


# International Financial Reporting and Analysis
