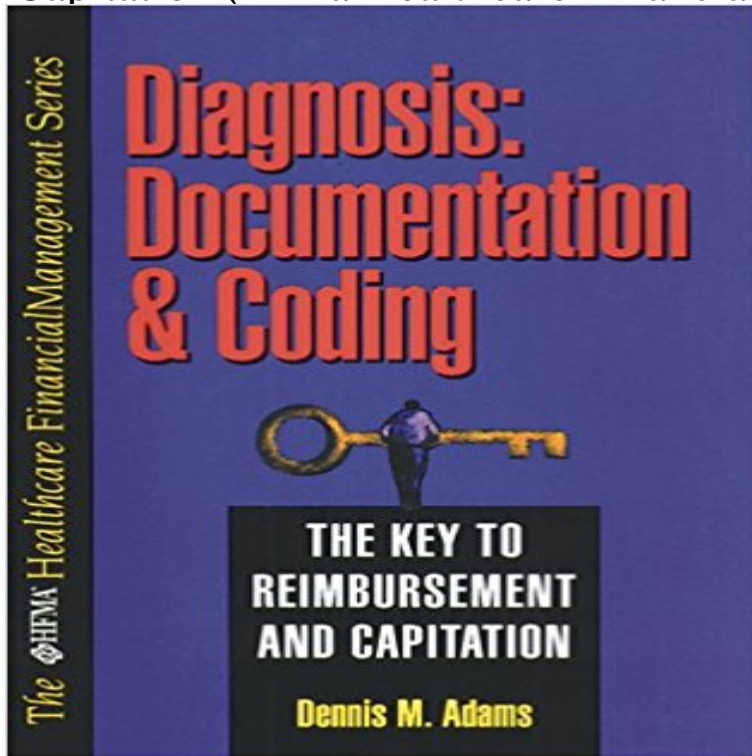


Diagnosis Documentation & Coding: The Key to Reimbursement and Capitation (Hfma Healthcare Financial Management Series)
