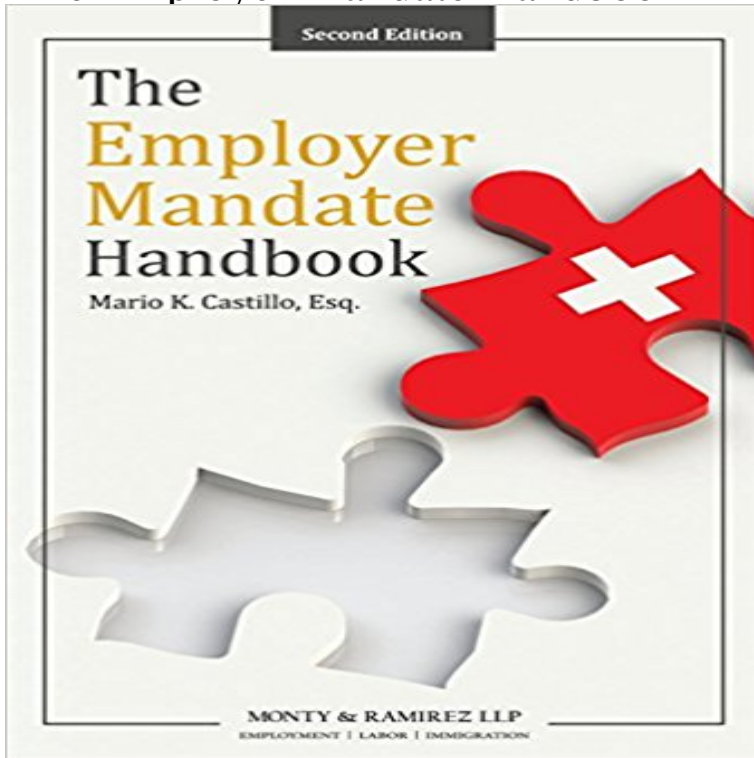


# The Employer Mandate Handbook
